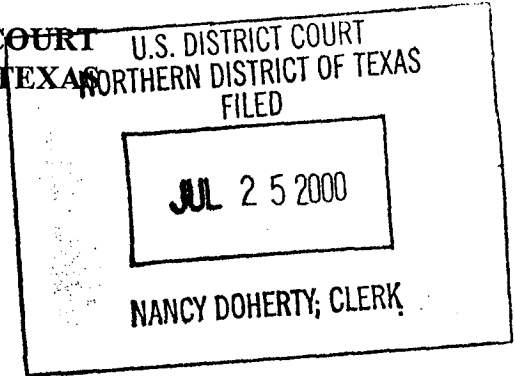

**RECEIVER'S PROPOSED LITIGATION BUDGET**

TO THE HONORABLE JEFF KAPLAN, UNITED STATES MAGISTRATE JUDGE:

COMES NOW, Michael J. Quilling ("Receiver") and, pursuant to this Court's Order entered on June 28, 2000, submits this his proposed litigation budget:

**Nature of Action And Good Faith Recovery Estimate**

This is an action by the Receiver to recover \$200,000.00 of investor monies given by receivership defendant Robert Cord (through an entity called Saber Industries) to defendant Morgan Weinstein & Co. The Receiver anticipates recovery of the \$200,000.00, plus pre-judgment interest (currently estimated to be \$42,000.00), reasonable attorneys fees and costs of court. The Defendants have already tendered \$152,000.00 to the Receiver to settle the case, which offer has been rejected. It is anticipated that this case will ultimately be settled.


