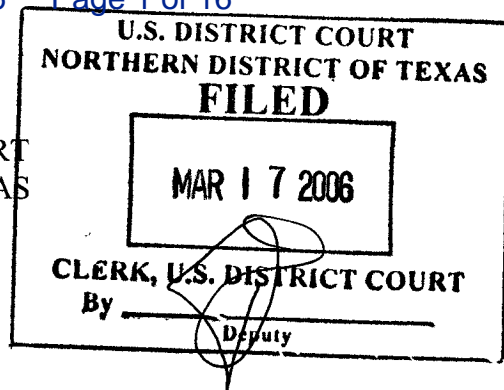

**RECEIVER'S PROPOSED BUDGET**  
**(Megafund Receivership Estate)**

TO THE HONORABLE JEFF A. KAPLAN, UNITED STATES MAGISTRATE JUDGE:

COMES NOW, Michael J. Quilling, the duly appointed Receiver in these proceedings ("Receiver") and, pursuant to this Court's order of March 1, 2006, submits this Proposed Budget (Megafund Receivership Estate).

1. As the Court is aware, these proceedings have been divided into three separate Receivership Estates. Accordingly, this budget will address the Megafund Receivership Estate as this estate has different issues and challenges which impact anticipated fees and expenses. In addition, in order to put the budget into perspective, a brief description of some of the issues are presented.

**Megafund Receivership Estate**

**a. General Matters.**

2. This estate is comprised of the assets and liabilities of Megafund Corporation, Stanley A. Leitner, CILAK International, CIG, Ltd. and James A. Rumpf. Based upon records currently available to the Receiver, approximately \$17,050,000.00 was raised by Megafund from investors (including Lancorp Financial) and approximately \$5,290,000.00 was diverted for improper purposes including *Ponzi* payments. Approximately \$11,760,000.00 of the funds were forwarded to CILAK/CIG, approximately \$2,260,000.00 of which was diverted for improper purposes including *Ponzi* payments. CIG forwarded \$9,500,000.00 of the funds to Sardaukar Holdings.

3. The goal of the Receiver is to first, determine who got the diverted funds and second, to recover as much of the funds as possible. Based upon the Receiver's efforts to date, approximately \$855,567.45 including interest has been recovered.

**b. Pending and Anticipated Litigation.**

4. The Receiver has filed several lawsuits relating to diversions of funds out of the Megafund Receivership Estate. None of the lawsuits have been referred to this Court for handling. They are as follows:

(i) *Michael J. Quilling, Receiver for Megafund Corporation and Lancorp Financial Group, LLC v. Kenneth Wayne Humphries*; Cause No. 3:06-CV-0299-R pending before Judge Jerry Buchmeyer. A lawsuit to recover \$19,000.00 in fraudulent transfers and damages of in excess of \$5 million for legal malpractice against a Kentucky lawyer who was Megafund's counsel.

(ii) *Michael J. Quilling, Receiver for Megafund Corporation and Stanley A. Leitner v. Urban Television Network Corporation*; Cause No. 3:05-CV-2395-N pending before Judge David C. Godbey. A lawsuit to recover \$665,000.00 in fraudulent transfers against a Texas corporation.

(iii) *Michael J. Quilling, Receiver for Megafund Corporation and Stanley A. Leitner v. MI-TY Productions, Inc.*; Cause No. 3:06-CV-0355-N pending before Judge David C. Godbey. A lawsuit to recover at least \$967,500.00 in fraudulent transfers against a California corporation.

(iv) *In re: International Galleries, Inc.*; Cause No. 06-30306-BJH-11 pending before Judge Barbara J. Houser. Claims have been asserted to recover fraudulent transfers in the amount of \$400,000.00.

(v) *Michael J. Quilling, Receiver for James A. Rumpf v. Bonanza Gold, Inc.*; Cause No. 3:06-CV-0474-B pending before Judge Jane J. Boyle. A lawsuit to recover \$30,000.00 in fraudulent transfers against a Washington corporation.

5. The Receiver anticipates filing several more lawsuits to recover fraudulent transfers as he continues to discover the identity and location of transferees.

**c. Physical Assets.**

6. The Receiver is currently in possession of a house at 2608 Gentle Drive, Flower Mound, Texas, and has it for sale for \$649,900.00. The Receiver is negotiating the return of approximately \$24,000.00 in an account at Rbtt Bank in the Netherland Antilles in the name of CIG, Ltd. The Receiver holds 60,000 shares of stock in Left Behind Games, Inc. and various items of artwork/equipment of nominal value.

**d. Claims.**

7. 149 claims have been submitted to the Receiver totaling \$13,245,786.58 through March 15, 2006 which appear to relate to the Megafund Receivership Estate.

**e. Budget Items.**

8. The Court's March 1, 2006 order sets forth stages to be budgeted, several of which really have no application as to the Receiver because the Receiver has no role in the litigation

between the Plaintiff and the Defendants. The Receiver's sole role is to marshal assets and identify liabilities.

### **Preliminary Investigation**

9. In that these proceedings have been pending for over eight (8) months, the Receiver's "preliminary" investigation stage has since passed. However, the Receiver's investigation continues and will continue until all assets have been identified, liquidated and claims established. In budgeting this stage the Receiver will assume that it is appropriate to account for the ongoing and future investigative efforts.

**Good Faith Estimation of Recoveries**

17. In addition to the recoveries already made (\$855,567.45) the Receiver anticipates that he will recover an additional \$775,000.00 plus whatever final distribution is made by the Sardaukar Holdings Receivership Estate to the Megafund Receivership Estate. In making this estimate, the receiver is estimating that he will recover 25%-50% of the amounts sought in each lawsuit. The Receiver is severely hampered in making such an estimate because he has no knowledge of the ability of a given defendant to pay any judgment awarded.

**Caveats**

18. No amounts are included in any budget materials for the Receiver's accountants and private investigators.


19. This budget does not include the fees and expenses incurred from the beginning of these proceedings through February 28, 2006 which total \$292,664.92.


