RECEIVER'S UNOPPOSED MOTION TO ESTABLISH CLAIM PROCEDURES AND TO APPROVE CLAIM FORM

TO THE HONORABLE H. BRENT MCKNIGHT, UNITED STATES MAGISTRATE JUDGE:

COMES NOW, Michael J. Quilling ("Receiver"), the Receiver appointed by the Court in these proceedings and files this his Unopposed Motion to Establish Claim Procedures and to Approve Claim Form and in support of such would respectfully show unto the Court as follows:

RECEIVER'S UNOPPOSED MOTION TO ESTABLISH CLAIM PROCEDURES AND TO APPROVE CLAIM FORM-

- 1. On October 11, 2001 the Court issued its Consent Order regarding the appointment of a receiver in these proceedings ("Consent Order"). Thereafter, on October 29, 2001 the Court issued its Order Appointing Receiver pursuant to which Michael J. Quilling was specifically appointed to serve as Receiver in this case.
- 2. Pursuant to the terms of the Consent Order, the Receiver was charged with, among other things, doing the following:
 - a. To provide all persons identified by the government as possible victims of the crimes described in the agents' affidavits in No. 3:98MC96-MU and other interested persons and potential claimants with notice and the opportunity to submit a claim to the Court, through the appointee, for restitution from the seized funds;
 - b. To review all claims submitted, evaluate their legal validity and sufficiency for payment from the seized funds, make recommendations to the Court as to the order and priority of payment, and provide subsequent notice of any disbursements or other actions by the Court or the appointee.
- 3. Since his appointment the Receiver has been diligently undertaking to accomplish the forgoing tasks. Although those efforts are far from complete, the Receiver believes that it would be prudent and help streamline the process to have the Court officially approve a claim form to be sent to potential claimants as they are identified. In that the identification of claimants is likely to take a considerable period of time, the Receiver does not believe it is appropriate to establish a date certain by which all claim forms should be returned. Instead, the Receiver requests that the Court order that the claim form, after it is sent to each potential claimant when they are identified, be returned within sixty days after the claim form is mailed to them. The Receiver does not intend to use such a deadline as a hard and fast rule to penalize claimants but rather only as a means to prompt a timely return of the completed form. The Receiver proposes to make exceptions to the deadline as circumstances dictate. A copy of the proposed claim form and a proposed cover letter to be sent

by the Receiver to investors are collectively attached hereto as Exhibit "A" and are incorporated herein by reference for all purposes.

4. In addition to mailing the claim form to potential claimants as they are identified, once the Receiver has received a completed claim form from a claimant he requests authority to send a postcard to the claimant confirming receipt. A copy of the proposed postcard confirmation is attached hereto as Exhibit "B" and is incorporated herein by reference for all purposes.

WHEREFORE, PREMISES CONSIDERED, the Receiver requests that upon final consideration of this Motion that the Court enter an Order consistent with the foregoing requested relief and for such other and further relief, general or special, at law or in equity, to which the Receiver may show himself justly entitled.

Dear Potential Claimant:

As you may be aware, I am the Receiver appointed by the United States District Court for the Western District of North Carolina, Charlotte Division to investigate and make recommendation to the Court as to proper and valid claims against approximately \$18.8 million of funds seized by the FBI in December 1998 from an account in the name of MM ACMC Banque de Commerce, Inc. at NationsBank in Charlotte. Records which I have reviewed indicate that you MAY have a claim to a portion of the seized funds. If you believe you have a claim of any nature whatsoever to the seized funds you need to carefully read this letter and the enclosure.

Enclosed with this letter is an Official Court-Approved Claim Form which you need to complete and return to me. As indicated in the Claim Form, when you complete and return the form it is important that you provide to me copies of any documents which you have relating to your claim. It is highly recommended that you send the completed Claim Form to me via certified mail. Be sure to keep a copy of the completed form for your records. The enclosed Claim Form was approved by the Court on _______, 2002. It is the ONLY Claim Form which will be considered in determining the amount of your claim. Accordingly, if you want me to consider and verify your claim you MUST complete the enclosed form, even if you have previously sent your information to me in another format. DO NOT SEND THE COMPLETED FORM TO THE COURT! SEND IT ONLY TO ME.

At the time the Court approved the enclosed Claim Form, the Court also ordered that you must complete and return the Claim Form to me within 60 days after I mailed it to you. Failure to return the Claim Form by the deadline may result in your payment being delayed and/or your claim being disallowed. **BE SURE TO COMPLY WITH THE DEADLINE**.

I believe the Claim Form is self-explanatory, but if you have questions, you may call my Claims Administrator, Steve Tomasky at (214) 880-1812. Because of the number of people involved, it may take several days for him to return your call. For those of you who have access to the internet you can also contact my office and Steve Tomasky at stomasky@asclpc.com. When I receive your completed Claim Form I will send you a post card acknowledging my receipt of your Claim Form. If you do not receive a post card from my office within ten (10) days after you send your completed Claim Form to me please contact Steve Tomasky at my office. After my office has an opportunity to review your completed Claim Form, we will contact you if we have any problems with your claim. There is no need for you to contact us, we will contact you. Repeated phone inquires by you will only delay and add to the cost of the process.
